

DISTRICT TITLE I PARENT AND FAMILY INVOLVEMENT POLICY

Parents and family of students participating in Switzerland of Ohio's Title I Program will be involved in the implementation of the Title I Program through the employment of the following activities in order to help them become a full partner in their child's education:

- d. Opportunity for individual conferences to discuss your child's strengths, needs, progress, interpretation of assessment, and/or proficiency levels. Parents and family will receive regular progress reports, and have the opportunity for training or the use of educational materials.
- e. Involvement in decisions regarding how allotted funds are spent; in making suggestions for parent and family training and sharing experiences; and in helping to coordinate parental and family involvement efforts with other local agencies, such as Head Start, Pre-schools, MACO, ABE, Bright Beginnings, etc., in order to develop a support partnership among school, parents and community.
- f. Assist in planning, reviewing and evaluating the Title I Program and the Parent and Family Involvement Policy by identifying barriers to parent participation, by making suggestions and by planning specific strategies for school improvement, which will be submitted with the LEA Plan.
- g. Reasonable access to staff, opportunities to volunteer and participate in their child's class, and observe classroom activities.
- h. Other activities when appropriate
