



School Parent and Family Engagement Policy Woodsfield Elementary

Building Capacity of School Staff

Woodsfield Elementary will provide training to educate teachers, specialized instructional support personnel, principals and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents and in how to reach out to, communicate with and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Professional Development during the monthly staff meetings, and staff “In-service” days.

Woodsfield Elementary will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- The principal will respond to any such questions, suggestions and issues as soon as possible.
